Approval of Minutes

The April minutes were approved (12 - 0 - 0).

President's Remarks

Simon apologized for moving the May meeting from its scheduled date.

He then explained that there had been an anonymous complaint to the ABC (Alcoholic Beverage Control) about alcohol consumption at the Club (happy hour & other events). Simon and Kim Howard have been talking to the ABC and committed to bringing the Club into conformance. While many details are still unclear, it appears that each month the Club will need to purchase daily permits (\$25/each) for every event where alcohol and non-Club members are both present. A. Lease Update

Fran explained that we're in the final stages of getting our new lease approved by the County supervisors. The one hitch is that the County wants minor changes to our bylaws to make the non-discrimination language align precisely with the County's. While we expect no substantive issue with the requested changes we do face process issues since our bylaws can only be amended at a membership meeting.

B. Bylaw Committee Update

Josh reminded the group that the Board had taken on the task of updating the bylaws in 2019 as part of dealing with the growth in membership. He also reminded the Board that the committee had defined a number of milestones where they would check in with the Board and that the first milestone was to split the existing bylaws into two documents: policies and procedures.

Policies would contain the "constitutional" stuff and would continue to only be amendable by the membership whereas procedures would describe implementation details and would be updatable by the Board.

Josh walked the Board through the portions of the current bylaws that the committee had designated as procedure. Nobody took exception to the committee's choices.

When asked for an example of an item that the committee considered a close call, he mentioned job descriptions. In particular one could argue that the job descriptions of the elected officers are static and should stay in the policy document whereas the commissioner job descriptions are dynamic and should migrate to procedure. On the other hand splitting the job descriptions in this way could make it awkward to locate a specific job description.

The committee will continue its efforts and report back to the Board when it reaches its next milestone.

C. Membership

Simon reported that 12 new members joined last month. He also indicated that Andy has taken the reins from Kathy (who has been very helpful in the transition).

Fran reported on a recent meeting and tour that included the major players (NPS, the Port, GGRNA, two County Supervisors, Chamber of Commerce, etc). The project has grown to include the replanning of the west side of the park to make Aquatic Park more accessible to locals and tourists arriving by way of Van Ness. She said the meeting was very constructive.

This meeting was followed by a visit to Senator Feinstein's office by Supervisor Catherine Stefani and representatives of the Chamber to explain the situation at Aquatic Park. As a result of the meeting,
