B. Funding for Master Boat Builder

Boatbuilder Jeremy Fisher-Smith has an impressive training and knowledge that he could share with our boat team. In fact, he built several of our Viking boats. We have a lot of boats that get a lot of wear and tear. After a 30-year absence Jeremy is willing to come to boat night and willing to help care for and fix our fleet and pass down learnings on how to care for our boats. He will charge a fee to come attend boat night. There was no ask for funds this evening, but the next Rowing Commissioner and Boat House Captain will be coming back to request some funding to support in 2024.

There are not many boat builders anymore and Jeremy is willing to come and impart his knowledge to our team to carry this on. He will teach us to fish. Teach us how to fix the Murphy and fix it the right way. We would build a skillset that is critical to carry forward for years to come. Boat builders are retiring, and this is a trade that may not carry on. We could pay Jeremy \$10K to fix the Murphy or we can learn from him to build our own expertise. Again, this will be on next

year's board to make this decision. Thierry recommended making a video archive for learning. We have many well-meaning volunteers who want to work on boats, but they need to truly learn and come together to do it the right way.
